Opinion Leaders may be used along with other strategies, such as reminders, audit and feedback, and distributing education materials.

We would be most appreciative if you could identify three (3) colleagues who you feel would be suitable to serve as "Opinion Leaders" (*i.e. someone you feel may be influential in the area of clinical practice*). These individuals should be people that you feel are <u>educationally influential</u>, <u>knowledgeable and humanistic</u>. In this context humanistic refers to someone who is concerned with the interests and welfare of others. Please let us know if you prefer having the opportunity to speak with the individual(s) prior to us contacting them.

Survey responses will be collated and nominated individuals will be invited to consider taking the role of an Opinion Leader. To help with the selection process, the following criteria will be considered by members of the selection committee: *Geographical location, past and current level of engagement with the profession, availability, attitudes and beliefs toward evidence-based practice and CPGs, prior teaching experience, and communication skills.* Selected individuals will be invited to participate in a training session to help them become more effective communicators and leaders when interacting with colleagues and other health care professionals.

2.Implementation Strategies and Support Tools

A number of Implementation Strategies and Tools are available to increase the likelihood of uptake of evidence in clinical practices.ⁱⁱⁱStrategies</sup> aimed at developing and maintaining professional competencies include distribution of printed educational materials, continuing education conference and workshops, educational outreach visits, patient-mediated interventions, audit and feedback, marketing, mass media, and regulatory interventions. **Support Tools** are resources for practitioners and those with a role in education that help improve and assess users' knowledge and apply the knowledge in practice. Tools include academic detailing aids; e-learning resources; patient and staff information handouts; webinars; Power Point presentations; Practitioner Guides, etc.
